

7TH ANNUAL IUOE LOCAL 139 POKER RUN-2024

PARTICIPATION AGREEMENT AND RELEASE FORM

I voluntarily agree to assume any risk of participating in the 7th Annual IUOE Local 139 Poker Run-2024 fund raising event ("Event"). I represent that I am at least 18 years of age, and if operating a motorcycle or other vehicle in the Event, that I have a valid driver's license and insurance as required by the laws of the State of Wisconsin.

I certify that I am experienced in and familiar with the operation of a motorcycle, automobile and/or UTV and fully understand the risks and dangers inherent in operating or riding in or on motorcycles or other types of motor vehicles. I am voluntarily participating in the Event and I agree to assume the entire risk of any accidents or personal injury, including death, which I might sustain to my person or property as a result of my participation in the Event. This means that I hereby release, waive, and discharge International Union of Operating Engineers, Local 139, AFL-CIO and American Legion Post 139 (the "Sponsors"), any other co-sponsors or fund-raising beneficiaries, including Hogs for Heroes, and their respective officers, directors, board members, agents, employees, volunteers, insurers, and all others involved in planning, conducting or participating in the Event (collectively, the "Released Parties"), from any and all liability to me and my heirs, next of kin, successors, assigns and insurers, for any and all losses, damages, expenses and claims for injuries (including death), and any other claims for damages that I or my heirs, next of kin, successors, assigns or insurers have incurred or may incur in the future, arising out of, resulting from, or in any way connected with my participation in the Event, due to or as a result of any action, inaction or negligence of the Sponsors, any Released Party or any other individuals or entities.

I hereby agree to indemnify and hold harmless the Sponsors and Released Parties from any loss, liability, damage, cost or expenses (including attorneys' fees) they have incurred or may incur in the future to defend any claims made or action taken against them by any individual or entity arising out of, resulting from, or in any way in connection with my participation in the event, whether as a rider or passenger.

Video recordings or photographs may be taken of the Event which may include my image, likeness, and/or voice ("Images"). By participating in the Event, I understand and agree that the Images may be used in the news or by the Sponsors and/or Released Parties for purposes of promotion, public relations, and/or marketing, and that such images or recordings may appear in print, on television, or on social media.
